Alongside the large revamp of the Constitution it felt right to have a look at other policies of the Union. Consistently in the past issues have been raised about the election regulations by Returning Officer's and recommendations have been made. There were two major issues identified, firstly the timeline for the election was quite unclear and also very demanding and unreasonable a timeline for the Returning Officer and others involved. Furthermore the election regulations as they are currently written lead to an additional unnecessary financial burden than need be. Lastly, it presented a fantastic opportunity to improve the election regulations in general, correct many grammar, spelling and reference errors and re-format the entire document.
