1. Notice of Motion No. 1: Affiliation to the Council of International Students Australia

- Mover– Searle

Preamble:

CISA is a democratically elected student controlled organisation. It is the peak body representing International students in Australia.

Student organisations can affiliate to CISA. The Union has already resolved to send delegates to the CISA conference. If we affiliate, these delegates will be voting members representing Swinburne.

In 2012 there is no cost for affiliation. Council previously agreed to spend \$1,200 from the SISA budget to send two delegates however due to the high costs of travel this amount needs to be increased.

Motion:

That the Union affiliate to CISA for 2012 and increase the travel allowance for the two delegates to \$750 each.

2. Notice of Motion No. 2: Education Conference Funding Pool

Preamble:

The Union has already allocated \$500 each to send four delegates to Education Conference. The funding is more flexible if it is treated as one \$2000 pool.

It appears that the initial expenditure for travel and accommodation is coming in at below \$500 each.

Motion:

That the President and Hawthorn Campus Chair will work with SSAA to hold Swinburne heats for the competition, and will promote these through Facebook, member emails and print media.

That Secretariat recommends a budget update to allocate \$250 to put towards heats and promotion of them.
